COMMITMENT TO YOUR PRIVACY

Thank you for viewing Giving4Paws, our website, which is owned and operated by Giving4Paws ("Giving4Paws, we, our or us"). This Site is designed to provide information about Giving4Paws and services associated with our community service operations. At Giving4Paws, we want to make your online experience satisfying and safe because we understand that you value your privacy, and we value it as well. To help you understand how we use any information you voluntarily provide to Giving4Paws, we have drafted this Privacy Policy ("Policy"). Our Policy governs information you voluntarily provide to us or we learn from your use of the Site. It also tells you how we may collect, use, protect, and in some instances share this information. This Privacy Policy is an agreement between you and Giving4Paws. If you do not agree to any of these terms, please cease using this Site and any of its interior pages. By viewing or using any of the information on this Site, you expressly consent to the information handling practices described in this Policy.

This Privacy Policy attempts to comply with the provisions of California Online Privacy Protection Act of 2003 enumerated under Business and Professions Code sections 22575-22579. THE INFORMATION GIVING4PAWS COLLECTS

Giving4Paws gathers several types of information about the Site's users:

Voluntary Information Collection

This site is designed to allow you to submit to Giving4Paws to receive certain types of personally identifiable information such as your:

- name;
- e-mail address,
- e-mail correspondence;
- postal mailing address,
- home/mobile telephone number,

- other user generated content.

You are not required to supply the aforementioned information, except if you wish to use certain features on the website. For example, the Site may call for a user to voluntarily create a user log-in profile/ID or permit an online donation. These features may require Giving4Paws to verify certain information so as to complete the requested transaction. As a part of the verification or profile process, you may be required to submit the personally identifiable information above.

Usage Tracking and "Automatically Collected" Information

Tracking Information

The Site automatically tracks and collects categories of information when you visit our Site such as the: (1) IP addresses; (2) domain servers; (3) types of computers accessing the Site; and (4) types of web browsers used to access the Site (collectively "Traffic Data"). Traffic Data is anonymous information that does not personally identify you but is helpful for marketing purposes or for improving your experience on the Site. We also may use technologies such as "cookies" and/or tracking pixels to collect information from and/or about you, and we do so, for example, to customize content specific to your interests, to ensure that you do not see the same advertisement repeatedly, and/or to store your password so you do not have to re-enter it each time you visit the Site. We also may use services provided by third parties to collect certain non-personally identifiable information on the Site through cookies, tracking pixels and similar technologies, which information may be used, for example, to display Internet advertisements tailored to your and other consumers' apparent interests.

"Cookies" Information

You do not need to have cookies turned on to use the Site. As stated above, "cookies" or text files may be placed on your computer when you use the Site. A cookie cannot read data off your hard disk or read cookie files created by other sites. Cookies may be of limited duration, which will disappear after you exit the Site or they may be there for unlimited periods of time, even after you leave the site. The cookie will enable us to understand and relate your use of this Site to information we provided or may provide in the future. Some cookies may contain personal information that you voluntarily provided. In addition, the cookie may be encrypted so as to authenticate you on other pertinent parts of the Site.

You do not need to have cookies turned on to use the Site. You should also note that you will be able to remove any of the cookies we place on your hard drive. If you feel you cannot do so, please e-mail info@giving4paws.org.

THE WAY GIVING4PAWS USES INFORMATION

Generally, Giving4Paws uses any information obtained from or for the site to operate and enhance the various features and services found on the Site, or, for other

components of Giving4Paws community service business. We use the personal information about you stored in our member database.

- To raise homeless animals awareness and generate donations to animal rescue partners;
- To assist you with finding a real estate agent to facilitate real estate transactions;
- To assist you in making voluntary donations to our rescue partners;
- To register you online for various events;
- To provide you updated Site information, publications or notices about/from Giving4Paws to improve Site flow and usability, tailor content to your needs, and make it more responsive to our users' preferences.

This Privacy Policy addresses only the use and disclosure of information we collect from you or that you disclose to us. If you disclose your information to others besides Giving4Paws, different rules may apply to their use or disclosure of the information you disclose to them. We do not control the privacy policies of third parties, and you are subject to the privacy policies of those third parties where applicable. Typically, a different privacy policy is triggered when you leave the Giving4Paws website.

Children

While this Site does contain information and content appealing to a host of people who care for animals, the Site is not primarily or directed to children or minors. Consistent with the federal Children's Online Privacy Protection Act of 1998 (COPPA), we will never knowingly collect or maintain personally identifiable information on the Site from anyone under the age of 13 without parental consent. IF YOU ARE UNDER 13 YEARS OF AGE, THEN PLEASE DO NOT USE OR ACCESS THE SITE AT ANY TIME OR IN ANY MANNER. Any person who provides their personal information to The SF SPCA through this Site represents that they are 13 years of age or older and represents that he/she has the express consent of his/her parent and is under the direct supervision of his/her parent. If Giving4Paws learns that personally identifiable information of persons under the age of 13 has been collected on the Site without verifiable parental consent, then Giving4Paws will take the appropriate steps to delete this information. If you are a parent or guardian and discover that your children under the age of 13 has obtained a Site account without your supervision or knowledge, then please contact Giving4Paws at info@Giving4Paws.org and you may request that Giving4Paws delete that child's personal information from its systems.

As stated above, we do not intentionally collect personal information directly from children under 13 years old. Parents may voluntarily supply information relating to their children for Giving4Paws related events. This information is never shared with third party organizations.

GIVING4PAWS TRANSFER AND INFORMATION SHARING POLICY

Giving4Paws may share personal information provided by you on this Site with third parties for various community services and other purposes. Unless described in this Policy or at the time we request information from you, we will not trade or sell anyone's personal information with anyone else, nor send mailings on behalf of other organizations. This policy applies to all information received by Giving4Paws, both online and offline, on any Platform ("Platform", includes Giving4Paws website and mobile applications), as well as any electronic, written, or oral communications.

The Site may include interactive forums such as message boards and chat rooms. Please remember that any information that is disclosed in these areas becomes public information and you should exercise caution when deciding to disclose your personal information. Please be aware, however, that any personally identifiable information that you voluntarily choose to display on any publicly available portion of the Site becomes publicly available and may be collected and used by others without restriction. To the extent such use has occurred, Giving4Paws is not responsible for any actions taken by those third parties. However, we may take down any information posted by any party by users.

Giving4Paws may disclose automatically collected and other aggregate non-personally-identifiable information with certain third parties to assist us with understanding the usage, viewing, and demographic patterns for certain programs, content, services, advertisements, promotions, and/or functionality on the Site.

Giving4Paws provides personal information to trusted businesses or persons for the purpose of processing personal information on our behalf. Thus, we may disclose user information to businesses or persons to: provide website hosting, maintenance, and security services; fulfill orders and requests; conduct data analysis and create reports; offer certain functionality; and assist Giving4Paws in improving the Site and creating new services and features.

We require that these parties process such information in compliance with this Privacy Policy, we authorize only a limited use of such information, and we require these parties to use reasonable confidentiality measures. If you do not want Giving4Paws to share your Contact Data with any third parties, please email us at info@Giving4Paws.org, however please understand that such a request will likely limit your ability to take advantage of all of the features and services we offer on the Site.

Except as otherwise provided in this Privacy Policy, we may disclose your personal information when necessary to: (a) comply with a court order or other legal process; (b) protect our rights or property; (c) enforce our Terms of Service; (d) protect Giving4Paws from fraudulent, abusive, or unlawful uses; (e) to initiate, render, bill, and

collect for amounts owed to Giving4Paws, (f) to investigate and defend ourselves against any third-party claims or allegations; (g) to assist government enforcement agencies; and (h) to protect the security or integrity of the Site; or to protect the rights, property, or personal safety of Giving4Paws, our users, or others.

Your Personal Information is stored on secure servers that are not accessible by third parties. We provide you with the capability to transmit your Personal Information via secured and encrypted channels if you use a similarly equipped web browser.

YOUR CHOICES

You may, of course, decline to share your personally identifiable information with Giving4Paws, in which case Giving4Paws will not be able to provide to you some of the features and functionality found on the Site. Your information and preferences may be deleted by you at any time, so long as you are in good standing with Giving4Paws. If, for whatever reason, a court of competent jurisdiction finds any term or condition in this Privacy Policy to be unenforceable, all other terms and conditions will remain unaffected and in full force and effect. No waiver of any breach of any provision of this Privacy Policy shall constitute a waiver of any prior, concurrent, or subsequent breach of the same or any other provisions hereof, and no waiver shall be effective unless made in writing and signed by an authorized representative of the waiving party.

The Site is controlled and operated by Giving4Paws from its office in the State of California. Giving4Paws makes no representation that any of the materials or the services to which you have been given access are available or appropriate for use in other locations..
